- One-twelfth of the shares subject to award vested on September 20, 2020 and then quarterly thereafter on each of December 20, March 20, June 20 and September 20, subject to the executive's continued service on each such date, until such units are fully vested on June 20, 2023.
- One-sixteenth of shares subject to award vested on September 20, 2021 and then quarterly thereafter on each of December 20, March 20, June 20 and September 20, subject to the executive's continued service on each such date, until the award is fully vested on June 20, 2025.
- One-sixteenth of shares subject to award vests on June 20, 2022 and then quarterly thereafter on each of September 20, December 20, and March 20 of each year, subject to the reporting person's continued service on each such date, until the award is fully vested on March 20, 2026.
